



# Mission, Values, and Vision

Cancer Legal Care's **mission** engages the law to resolve the complex challenges facing people and communities affected by cancer.

We live our mission through our values of

Being Driven to Challenge the Status Quo

In the service of the larger **vision** we hope for a world that embraces equity and justice as fundamental to health.

Cancer Legal Care's model of care provision and statewide reach is unique in the nation, advancing the inclusion of legal services into whole-patient cancer care as a means of addressing the social determinants of health and cancer's financial toxicity.

Cancer Legal Care has been providing free legal services to members of the Minnesota cancer community since October 2007. To date, more than 13,700 Minnesotans, residing in 78 of Minnesota's 87 counties, have received legal information and/or direct legal services via our various program offerings, valued at more than \$20,000,000.

We advance our mission by using both staff and volunteer attorneys across the state and by reducing as many barriers to accessing the advice and information our clients need by making them open to:

- any resident of Minnesota, affected by
- any cancer,
- at any income level,
- at any stage from diagnosis through end-of-life.

For the last five years, Cancer Legal Care's work has focused on reducing cancer's financial toxicity which has a disproportionate effect on

- · historically marginalized communities,
- those living in Greater Minnesota,
- · Iow-income Minnesotans, and
- Minnesotans who facing tremendous medical debt due to provider billing or health insurance coverage denial issues.

Cancer Legal Care's services are always provided free of charge to our clients.

# Our clients have a wide range of needs.

## How your donations are helping:

- 17% Insurance Coverage (health insurance treatment denials, short/long term disability)
- 12% Housing and Financial (eviction, foreclosure, creditor issues, bankruptcy)
- 8% Employment (ADA discrimination/reasonable accommodation, FMLA)
- 22% Legal Planning (health care directives, guardianship, wills, powers of attorney)
- 33% Public Benefits (Social Security Disability, Medicaid)
- 8% Other (immigration, family, business)

### Who your donations are helping:

- 633 clients, with 831 legal issues (up 27% and 32%, respectively, over 2022)
- Women 58%, Men 41%, Transgender 1%
- 48% have a household income under 200% of the Federal Poverty Guidelines
- African American 9%, AI/AN 1% Asian 3%, Hispanic 4%, Multiracial 1% ME/NA 1% Unknown 4%, White 77%
- 75% reside in the Twin Cities metro; 25% in Greater Minnesota
- 41% live alone
- 23% have minor children in their home and care
- 84% are still of working age
- 58% are living with a Stage IV cancer
   (70% if counting only those who know the stage of their cancer)
- 33% sought help with a Social Security disability benefit issue or other government benefits issue (up from 17% in 2022)

# Program Highlight: Insurance Claims and REsolution (ICARE) Program

Since beginning this work in 2019, the ICARE Program has closed complicated insurance matters on behalf of 160 clients with a **96% success rate**. Of these matters, success included **protecting or recovering \$4,066,034** in health, disability, or life insurance benefits that had initially been denied to 64 clients. Without Cancer Legal Care's intervention, these 64 clients would have been personally responsible for these costs, ranging from \$135-\$565,000, with an average of \$63,532 saved for each client.

# **Social Security Application Assistance Program**

Launched on January 1, 2023, funded in part with a four-year contract with the Minnesota Department of Human Services, the SSAAP marks the start of something our clients have long asked for: hands on help at every step of the SSDI/SSI application process. Offering this expanded service has been a huge success, with over 250 clients coming to us for help with all types of Social Security, and related benefits issues.

I am so grateful for the help I received from Cancer Legal Care, I was denied disability and needed help to file an appeal. When I was diagnosed with Stage 3 Breast Cancer my boss suggested I file for SSDI since my ability to work was so drastically cut. It was very difficult trying to do SSDI paper work with chemo brain, it took me 2 weeks! I had no idea there was help out there and wish I knew about your services from the beginning. It would have dramatically decreased my stress, just knowing someone was there for me.

I was under so much stress, from my treatment to trying to pay medical bills and our income cut in half. When I received my denial I was in tears. I reached out to Cancer Legal Care and was blessed to speak with Meghan, she was a godsend! She was patient, explained everything and made it so easy for me to move forward. I spoke to her on many occasions, she was like a superhero to me. I felt like she truly cared about me, about my story.

# What our clients want you to know

Cancer Legal Care was fortunate to receive funding in 2023 from the Shavlik Family Foundation to partner with our clients and researchers at the University of Minnesota to conduct a comprehensive client survey as we plan for the years ahead.

#### What we were eager to know:

- · what was and wasn't working with our process of providing legal services;
- how effective our services are at answering their questions and helping to resolve their legal issues;
- barriers they faced in accessing legal services;
- their experience with cancer's financial toxicity;
- and their confidence in applying for Social Security disability benefits.

#### What we learned:

- 93% of respondents indicated that *CLC was able to resolve* all (70%) or most (23%) of their legal concerns
- **78%** of respondents indicated that cancer had a profound (44%) to moderate (34%) *impact on their finances*
- 75% of respondents indicated a preference to contact CLC by phone and
   41% by video conference. This compares to 38% in CLC's offices or 30% in their cancer clinic
- When asked about when would be the best time to be referred to CLC, 66% indicated at diagnosis, and 35% at the start of treatment
- The top three reasons for *hesitancy or barriers* in contacting CLC were
  - Feeling overwhelmed by other responsibilities (57%)
  - Worried about what the lawyer might say (38%)
  - Concerns about cost (33%)
- 40% responded that they would not feel comfortable applying for Social Security disability benefits without professional help

My nephew Michael was married to a beautiful woman, Brittany, who died at age 31 from breast cancer. Michael and Brittany had been married 5 years and their son was just two years old. After Brittany's death, in addition to dealing with the devastating loss, there was much to do to sort out finances, medical bills, insurance, child care, and the like.




